The project aims at improving the capacity of local councilors with particular focus on new elected and female councils who are frequently face greater challenges in performing their functions. The project will support the Association of Sub-national Administrative Council to adopt six mandatory training modules for councilors in which one of the module on gender equality.

The project aims at helping the local government to formulate and implement a delegated function on Solid Waste Management (SWM), which has been recognized by the local councils as the most complicated function and there has not been any best example for replication throughout the country yet.
