

**FIRST AMENDMENT TO THE MICRO-CAPITAL GRANT AGREEMENT  
BETWEEN  
THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)  
AND CAMBODIAN DISABLED PEOPLE'S ORGANISATION (CDPO)**

Reference is made to the Grant Agreement dated 17<sup>th</sup> July 2018 signed between the United Nations Development Programme (UNDP), and Cambodian Disabled People's Organisation (CDPO), with respect to the implementation of the Project no. 00104469, Access to Justice without Barriers for Person with Disabilities.

As per UNDP Rules and Regulations, any modification of or change to this Agreement shall require an amendment signed by both parties namely authorized representatives of the Grantee and UNDP.

Therefore, the parties hereby agree on the following:

**WHEREAS** UNDP and CDPO have agreed to amend such agreement in order to scale up project activity with additional cost.

**NOW, THEREFORE**, the relevant agreement provisions indicated below are hereby amended to read as follows:

**CLAUSE III: Payments**

**3.1** UNDP shall provide funds to the RECIPIENT INSTITUTION in an amount up to **USD50,000** (fifty thousand US Dollar only) according to the schedule of Annex 1 Revised Budget set out below and Annex 4 – Revised Payment Request. Payments are subject to the RECIPIENT INSTITUTION meeting the outputs as specified in Annex 2- Performance Targets.

- **First Tranche: USD13,979** upon signature of original agreement
- **Second Tranche USD33,291** upon satisfaction by Assistant Country Director (ACD) of receipt and acceptance of progress report, annual report and project completion report on use of funds by 28 February 2019.
- **Third Tranche USD2,730** upon satisfaction by Assistant Country Director (ACD) of receipt and acceptance of progress report, annual report and project completion report on use of funds by 30 November 2019.

**NEVERTHELESS**, all other terms and conditions except as amended herein, shall remain unchanged and shall continue in full force and effects.


