Brief project description: This project seeks to deepen the engagement of Uruguay with the GCF, continuing the efforts that were initiated under previous funding for readiness support in 2017. The initial coordination mechanism, which has been established and led by the NDA (MVOTMA), will be maintained and strengthened among involved institutions, looking for a systematic and streamlined participation of all potential beneficiary sectors, including the private sector and civil society, and a better engagement with the Fund opportunities. The GCF-Country Programme adaptation priorities will be updated building on the NAPs processes currently under development (agriculture, coastal, and cities and infrastructures). The project also seeks to strengthen the NDA through south-south and triangular cooperation sharing experiences and lessons learnt with other regional NDAs. A Climate Change and Gender Strategy/Plan in the framework of the Country Programme will be elaborated, to assure gender responsiveness as a cross cutting issue. The NDA will also support the accreditation processes of the two-nominated potential Accredited Entities.

7. Brief summary of the request	<p>1. In the last years, Uruguay has increased its political commitment in relation to climate change aspects. At the institutional level, there is a deeper involvement of relevant stakeholders and early actions have been taken to face the impacts and to mitigate the causes of climate change. Being a highly vulnerable country, Uruguay has facilitated adaptation measures in priority sectors, such as agriculture, coastal areas and risk management. Regarding mitigation, the country achieved the de-carbonization of the electric grid and an increase in the participation of renewable energies in the primary energy mix. In this framework, the country has developed, in a participatory manner, the National Climate Change Policy 2050 during 2016 and in 2017 Uruguay developed and submitted the first NDC under the Paris Agreement. Both have been approved by the Government in November 2017 (Decree Nº 317). These instruments strengthen the national institutional framework to face climate change and at the same time contribute to increase public awareness on this issue. Recently, the country has made progress in National Adaptation Plans, which cover sensitive sectors of the economy and society. In particular, the NAP in agriculture sector, the NAP in coastal areas and the NAP for cities and infrastructure are being rolled out in a coordinated manner with other projects and processes that are under implementation, including energy efficiency initiatives in different</p>		

sectors, sustainable transport in cities and a binational project for implementing adaptation measures in border cities and natural ecosystems, among others.

2. In 2017, Uruguay received funding from GCF for readiness Support, which is now being rolled-out by UNDP under the guidance of NDA. This support, expected to be finalized by December 31st, 2018, has allowed for:
 - the NDA to finish its Country Programme Brief that was presented in the first Structured Dialogue of Latin America and the Caribbean in March 2018;
 - the development of one project idea identified in the Country Program Brief into a funding proposal with a Direct Access Entity regarding the acceleration of electric mobility to be submitted and assessed in 2019 within the Private Sector Facility. This idea was awarded as one of the thirty best concept notes in the Mobilizing Fund at Scale RfP;
 - the initiation of two other project ideas regarding climate services and urban adaptation in coastal areas;
 - to consider for nomination two other regional Direct Access Entities and to nominate a second national Direct Access Entity (BROU);
 - to follow up on the accreditation process of its two nominated national Direct Access Accredited Entity (CND and BROU);
 - strengthened the capacities of the NDA to consider funding proposals presented by Accredited Entities in the NOL procedure, and build specific relevant capacities in the Environmental and Social Policy and in gender issues
 - Drafting and signature of the Privileges and Immunities Agreement of the Green Climate Fund in Uruguay.
3. In this context, the request made herein for additional readiness funds will allow continuing efforts to deepen the engagement of Uruguay with the GCF. UNDP has been selected as delivery partner, to facilitate the continuity of the processes, actions and team of experts, which have supported the NDA in a highly satisfactory manner.
4. An initial coordination mechanism has been established and led by MVOTMA comprising: a direct daily involvement of the Ministry of Economy and Finance. MVOTMA reports all NDA actions and decisions, such as proposal prioritization and the strategic guidelines of country programming to the National Environmental Cabinet (comprised of the President of Uruguay, the Environment, Water and Climate Change National Secretariat, and the Ministries of Housing, Land Planning and Environment, Agriculture, Industry, Energy and Mines, Health, National Defense and Economy and Finance). MVOTMA also consults with relevant stakeholders in the framework of the National Climate Change Response System, which is developing an integrated PNCC-NDC MRV tool, which includes climate finance tracking and the GCF Country Programme.
5. This coordination mechanism will be maintained and strengthened among institutions involved, looking for a systematic and streamlined participation of all potential beneficiary sectors, including the private sector and civil society, and a better engagement with the Fund opportunities. This will be implemented through regular meetings in person among the main institutions of the Coordination Mechanism (public institutions involved) and in a more flexible basis for other relevant stakeholder: through specific meetings and workshops regarding particular topics, and looking for the engagement of specific private and civil society actors. This mode of functioning will be complemented by fluid virtual communication. Apart from that, the project seeks to strengthen the NDA through south-south and triangular cooperation, sharing experiences and lessons learnt with other regional NDAs.
6. Under the framework of the National Climate Change Response System, there is an inter-institutional working group focused on the MRV of the National Climate Change Policy and the measures included in the NDC. The group also works on programming some of the measures included in the Climate Change Policy and in the NDC that are not being developed yet. As it can be seen, there is a clear link among these activities and the contribution that the support project will make: the assessment and update, as appropriate, of the country programme



	<p>currently in place will relate and complement the work being made by the MRV working group. In this regard, the stakeholder's involvement will be enhanced through the development of additional activities and workshops. The private sector participation is considered as crucial in the update of the country programme (maintaining the balanced approach between adaptation and mitigation) and in specific initiatives regarding the GCF Private Sector Facility, for which its involvement will be encouraged.</p> <p>7. A Climate Change and Gender Strategy/Plan in the framework of the country programme will be elaborated, to assure gender responsiveness as a cross cutting issue.</p> <p>8. As previously mentioned Uruguay currently has two potential Accredited Entities under the process of accreditation. In this sense, the NDA will continue to support those processes.</p> <p>9. Qualitative progress will be achieved under this new support from the GCF, since the private sector is expected to engage in specific initiatives and invest in climate friendly projects/programmes. This initiatives are expected to emerge from the different exchanges with the stakeholders, and at the same time to be aligned with the Government lines of work, objectives (NDC) and specially the areas considered under the country programme with the GCF (resilient housing, water resources, transport, etc).</p>

SECTION 3: ADDITIONAL INFORMATION

1. During the last years Uruguay has strengthened its climate change institutional arrangements on one side, and implemented early and effective measures to tackle this phenomenon, on the other. In particular, in 2017 the Government approved the National Climate Change Policy –PNCC- (elaborated under a participatory process during 2016) and the country submitted its first NDC to the Paris Agreement, in the framework of and consistent with the PNCC. Uruguay is extremely committed to undertake a sustainable development pathway, with a climate change perspective, and in this sense, the GCF gives an opportunity for the public and private sector to engage with sustainable investments for implementing adaptation and mitigation measures.
2. Uruguay is particularly vulnerable to the adverse effects of climate change. Every year it is impacted by extreme events such as severe storms, floods, droughts, cold and heat weaves, high winds, tornadoes, hail, frost and heavy rain affecting our populations, infrastructure, productive processes and our ecosystems and biodiversity. Our economy is based on the agricultural sector. The vulnerability that the sector presents is particularly relevant regarding the country role in the food production and in terms of food security at a global level.
3. In order to deal with climate change impacts, among other measures, Uruguay is carrying out the elaboration of National Adaptation Plans. These plans cover three of the main sectors for the national economy: the national adaptation plan in Agriculture, and the National Adaptation Plan for cities and infrastructure through the GCF Readiness Support. As established in the Uruguayan NDC, to implement these and other related measures, the country will make relevant efforts but will also need to receive support from the international community. In this sense, this Readiness Support will contribute to incorporate the adaptation measures identified through the 3 NAPs in the Country Programme, and to engage the private sector in the related financing and investment opportunities for adaptation.
4. Uruguay has already reached a structural transformation of its electrical matrix, with a share of renewable energy of 96%. Even if renewables account for more than 50% of the global energy mix, there is still need to make progress on others subsectors, mainly in transport. In that sense, the NPCC establishes that transportation systems will be more sustainable through increasing efficiency and the combination of energy sources and technologies of lower GHG emissions, tending to a GHG reduction in the sector. The NDC presents mitigation measures related to more sustainable transport systems. In that regard, the country is submitting a full proposal to the Private Sector Facility of the GCF during 2018, with the support of the Readiness Support Project, to accelerate the introduction of electric mobility in the public transport subsector. It is expected that this stage will contribute to a major change in the transport sector in the country in the medium and long term.
5. The Country Programme is being elaborated in the framework of the PNCC and the NDC, and helped to prioritize adaptation and mitigation measures for implementation with the support of the GCF, all of which have relevant co-benefits for the population and sectors involved. This tool is supporting the concretion of project ideas that are being submitted to different GCF windows during 2018.


