**Evidence:**

On February 18, 2020, the Project's National Partner - Women's Committee of Uzbekistan was transferred into the Ministry of Mahalla and Family Support of the Republic of Uzbekistan according to the Presidential Decree PF-5938. According to the official letters from the Ministry of Foreign Affairs and Ministry of Mahalla and Family support of the Republic of Uzbekistan, the new Ministry became the National Partner of the Project, the new Project Coordinator appointed and the Project Document, the Letter of Agreement, the Annual Plan of Activities was updated and re-signed with the new National Partner. Also, due to Covid-19 related situation in Uzbekistan, the Project identified the main needs of the communities in rural areas, as well as the needs of the newly established Ministry, signed the Annual Plan of Activities and implemented the joint project with other UN Agencies.

**Evidence:**

Gender equality and women empowerment is still the most critical priority of the Government of Uzbekistan, with half of the women population -17 mln. Thus, in order to reach a sufficient number of beneficiaries, there is a plan to scale up the project by using project results to advocate for policy change. Thus, the new Project document on gender equality was drafted for 2021-2024 and submitted to the Gender Commission of the Republic of Uzbekistan for review and consideration.

The project team has systematically gathered data and evidence through project monitoring on the relevance of the measures to address gender inequalities and empower women. Analysis of data and evidence was used to inform adjustments and changes. Also, the Project, based on the collected data and evidence, supported the National Partners - Women's Committee of Uzbekistan, Ministry of Mahalla and Family support to draft the Presidential Decrees, Laws on gender equality and women empowerment. As a result of this cooperation, two gender laws in Uzbekistan was adopted in 2019, Presidential Resolution on the shelters for the victims of gender-based violence, Resolution of the Cabinet of Ministers of Uzbekistan on the gender-legal expertise was adopted in 2020, 2021. Also, the Project twice received UNDP awards during the four-year implementation - "Best Project" in 2019 and "Gender Champion" in 2021 for the activities to address gender inequalities and women empowerment.
