The project is seeking to reduce the energy related costs connected to a broad range of various social and other public services offered by municipalities such as education, health, public lighting, heating. The related financial savings can contribute to further enhancing or maintaining the quality and availability of such services, and thereby further contribute also to equal human rights to safety, healthcare, education etc. By a system facilitating public monitoring of energy and water consumption (and related costs) within any particular municipality and their facilities, the project will also create an enabling environment for increasing public participation to influence municipal decision making and improve its accountability.

##### *Briefly describe in the space below how the Project is likely to improve gender equality and women's empowerment*

The socioeconomic benefits to be delivered by the project include the creation of green jobs, improving energy supply and security, catalyzing private investment and contributing to the improved comfort and sanitary conditions in public buildings, thereby also improving the working environment of the people working in those buildings. Out of these, more than 50% are women. The employees and users of public buildings and services are also encouraged to come up with their own ideas for energy savings and improved energy efficiency, which is facilitated, among others, by project's public awareness raising activities, possible competitions etc. As needed, such activities can also focus particularly on encouraging the participation of women.

Mainstreaming environmental sustainability is in the core of project strategy by introducing and providing tools for environmentally sustainable management and operation of all Serbian municipalities.
